

# THE NSUKKA BROTHERS' CLUB OF NIGERIA

## THE CONSTITUTION OF THE NSUKKA BROTHERS' CLUB OF NIGERIA

### Section 1

The Association shall be known and called: The Nsukka Brothers' Club of Nigeria aka "Comrades". it is a social club.

**Motto:** Our oral greeting is "Comrades" while the response is "Brothers" whereas in formal communication like letters, notices, mails, etc we shall use "in Unity we Stand".

**Logo:** it is an "Eagle"- we are eagles; we are unique, outstanding, soaring and excellent in our areas of endeavors. it would be used as an insignia on our letter head, constitution, notice and other club formal communications/branding.

### Section 2

#### 1. AIMS AND OBJECTIVE:

- i. To make contributions for the advancement and promotion of charitable or benevolent activities and organization in Nsukka;
- ii. To protect, defend and promote the welfare of members' Communities;
- iii. To provide a forum for social and cultural interaction among members;
- iv. To foster and strengthen the bonds of unity among members wherever they may be.

#### 2 MEMBERSHIP AND REGISTRATION OF NEW MEMBERS:

- i. Membership shall be open to all married men or widower from Nsukka.
- ii. The vetting of a prospecting member; need to be thorough, his source of income must be legal and able to support the activities of the club.
- iii. His sponsors must vouch and commit to the integrity and financial viability of a candidate.

## THE NSUKKA BROTHERS' CLUB OF NIGERIA

- iv. Any person who has been convicted of any criminal offence shall not be eligible to join.
- v. The membership ceiling is 30 (thirty) members.
- vi. A registered new member would be in a mandatory probation of 1 (one) year from the date of registration, within the period he shall not enjoy any privilege.
- vii. An intending applicant shall obtain a membership form from the Secretary on payment of a non-refundable applicant fee of ₦ 20,000.00 (Twenty thousand naira only) to the financial secretary, who shall issue him a receipt for the payment.
- viii. A successful applicant shall be registered upon payment of a fee of ₦1,000,000.00 (one million naira only) and a cartoon of Andre Rose wine.
- ix. There shall be no registration by proxy, every registered member shall be entitled to an identity card upon payment of a fee to be determined by members of the club.
- x. The applicant has only one month to return filled form and two months to get registered by paying the registration fee in part or full. There is six months window to complete the payment.
- xi. An identity card shall be endorsed, before insurance by the Chairman or Secretary and same shall be renewed after every four years.
- xii. The preferred age bracket for an intending member shall be between 35 and 50 years of age.
- xiii. 6 (six) financial members form the quorum of the club's meeting.

3. **DISTANCE MEMBERSHIP:** A member who has been regular at meeting for at least 2 years may apply to be a distance member under the following conditions:
  - a. If he relocates to a place more than 20kms from Abuja and wishes to continue his membership of the club and applies in writing.
  - b. If he nominates a reputable financial member to represent him.
  - c. If he promise, in writing to attend meetings in person, once every four months.

### **Section 3**

#### **A. SECRETARIAT AND MEETINGS:**

- i. The secretariat of the club shall be located in Abuja.
- ii. Our meetings shall be rotated at our homes. We shall buy for the meetings: 10 gallons of up palm wine from our purse.
- iii. From the next circle of meeting hosting, our host shall receive the sum of ₦150,000 (one hundred and fifty thousand naira only).
- iv. Our host must present:
  - a. Dressed table and chairs.
  - b. Buffet with minimum of 2 (two) soups (bitter leaf, egusi, vegetable, ogbono, etc) with corn food, semolina, wheat, etc.
  - c. 2 (two) flavours of rice as the minimum, 1 (one) local food and at least 1 (one) pepper soup

- d. The protein must be he-goat meat, chicken and fish
- e. 4 (four) bottles of baileys, 2 (two) bottles of Jameson black whisky, 2 (two) cartons of non-alcoholic drink, 6 (six) bottles of Andre rose wine, 1 (one) mixed carton of beer, 1 (one) carton of stout & cartons of bottle water.
- f. Our official drink Jameson black whisky, it should be used in all our meetings.
- g. The monthly meetings shall commence at 3.00 pm and must end by 8.00 pm: quorum is 6 members. Lateness commences at 3:15 pm prompt and whoever that comes after the time, shall pay ₦ 1,000.00 (one thousand naira only) before sitting down or greeting members.
- h. The monthly due is ₦ 10,000.00 (ten thousand naira only); this would be reviewed as the need arise.

## **B. DECISION AT MEETINGS**

- i. Decisions reached at meeting shall be by Consensus, and failure to achieve consensus, the view of the majority shall prevail.
- ii. The view of the majority shall be determined by simple vote of members present at the meeting.
- iii. When there is a tie, the Chairman should vote to break the tie

## **Section 4**

### **A. ORGANS OF THE CLUB**

The club shall have the following organs:

1. General membership- this is made up of all the members of the club
2. Board of Trustees (BOT)
3. The executive shall be made up of:
  - i. The Chairman
  - ii. The Vice chairman
  - iii. The Secretary
  - iv. Assistant Secretary
  - v. Treasurer
  - vi. The Financial Secretary
  - vii. Assistant Financial Secretary
  - viii. The Public Relations Officer (PRO)
  - ix. Provost
  - x. First Assistant Provost
  - xi. Second Assistant Provost
4. The Legal Adviser

The Executive shall have the cardinal function of executing the decisions of the club. The executive shall meet as the need arise.

### **5. DUTIES OF OFFICERS:**

- a. The chairman shall have the following duties
  - i. He shall preside at meetings
- ii. He shall co-ordinate the activities of

the club.

- iii. He shall cast his vote when there is a tie.
- iv. He shall authorize all expenditure on the advice/s or approval of the club.

**b. The Vice Chairman shall:**

- I. Assist the chairman in the performance of his duties.
- ii. Carry out all the duties of the Chairman in his absence.
- iii. Perform all other duties as may be assigned to him by the Executive or the club.

**c. The Secretary Shall:**

- i. Keep the records of the club and take minutes at all meetings.
- ii. Prepare the club's annual and other reports.
- iii. Convene meetings of the club as directed by the Chairman.
- iv. Administer the Secretariat of the club.
- v. Perform any other duties as may be assigned to him by the Chairman or the club.

**d. The Assistant Secretary Shall:**

- I. Assist the Secretary in the performance of his duties
- ii. Perform the duties of the Secretary in the absence of the Secretary.

iii. Perform any other duties as may be assigned to him by the Secretary or the club.

e. **The Treasurer Shall:**

- I. Receive all monies collected on behalf of the club and shall pay same into the club's account and submit statement of all transactions to the financial secretary of the club for proper record keeping.
- ii. Give receipt to monies paid out.

f. **The Financial Secretary Shall:**

- I. Receive and hand over monies to the treasurer.
- ii. Maintain a proper record of all financial transactions of the club.
- iii. Prepare financial reports and statements of account of the club.
- iv. Perform all other duties as may be assigned to him by Chairman or the club.

g. **Assistant Financial Secretary**

- I. Assist the Financial Secretary in the performance of his duties.
- ii. Perform the duties of the Financial Secretary in the absence of the Financial Secretary.
- iii. Perform any other duties as may be assigned to him by the Financial Secretary or the club.

h. **The Public Relations Officer (PRO)**

- i. Ensure an adequate level of public enlightenment and awareness of the programmes and activities of the club.
- ii. Be the chief image maker of the club
- iii. Perform any other duty as may be assigned by the Chairman or the club.

i. **Provost:**

- ii. Shall be responsible for the maintenance of peace, law and order during meetings and other social occasions of the club.
- iii. Shall during every Session or event, collect fines from defaulting members and handover same to the Financial Secretary.
- iv. Shall perform other functions as may be directed by the chairman or the Club.

j. **First Assistant Provost:**

He shall assist the provost in the performance of his duties and shall carry out functions of the provost in the absence of the provost.

k. **Second Assistant Provost:**

He shall assist the Provost and the Assistant Provost in the performance of their duties and shall carry out any of the functions of the Provost in the absence of the Provost and the first Assistant Provost.



## Section 5

### **Tenure of Officers and Qualifications**

- I. The tenure of office of all elected officers shall be four (4) years from the date of the election.
- ii. Only members who have stayed two years and above, and are financially up to date, shall be eligible for election.
- iii. Only members who are (6) months and financially up to date can sponsor or surety or nominate any person to an elective position or any position of honour or responsibility, as the case may be.
- iv. All elected officers must be resident in Abuja.
- v. Any member aspiring to the office of Chairman, Vice Chairman, Secretary General and Financial Secretary shall have:
  - I. Been a member of the Club for at least three (3) years, proceeding the date of the election.
  - ii. The ability to read, write and communicate.
  - iii. Proven integrity and must not have been convicted of any offence or misdemeanor or involving dishonesty or fraud.
  - iv. No officer shall hold office for more than two (2) consecutive terms.
  - v. An officer may be re-elected to another office after serving out two terms in one office.

## **Section 6**

### **A. THE BOARD OF TRUSTEES (BOT)**

- i. Act as the conscience of the club.
- ii. Provide advisory services to the club.
- iii. Conduct elections for the club
- iv. To qualify for appointment as a BOT, such a person must be above 45 years and must be a man of integrity.
- v. The BOT shall act as the father of the club and may be contacted or consulted from time to time with regard to any issue, doubts or opinions affecting the club.
- vi. A BOT member may enjoy his office for life, though could be removed for good cause shown by the club or as provided for in this constitution.

### **B. DUTIES OF THE BOT:**

- i. The BOT shall be vested with the power of conducting elections after the dissolution of an outgoing executive in accordance with the constitution.
- ii. BOT membership doesn't have tenure, the club can replace a member any time at its discretion.

## **Section 7**

### **COMMITTEES**

#### **A. THE EXECUTIVE**

This shall comprise all elected officers plus other 3 members nominated from the floor of the club

##### **FUNCTIONS:**

- i. The Executive: Shall hold meeting as the need arise.
- ii. Shall discuss such matter that affect the club for ratification or approval.
- iii. Shall discipline erring members and have the power to impose fines and suspension as appropriate.

#### **B. DISCIPLINARY COMMITTEE**

The body is constituted to handle all disciplinary matters bestowed on it by this constitution and referred to it by the executive or the Chairman.

##### **FUNCTION: -**

- i. To maintain order during our sittings or at events.
- ii. To collect fines from defaulting members and to render accounts to the Financial Secretary of the club.
- iii. To give accounts of such collections during meetings.
- iv. Shall be constituted to help recover debts, properties or other monies belonging to the club.

### **C. POWERS**

- i. The Executive is empowered by this constitution to collect money from any defaulting member.
- ii. Shall keep all generated income and render such account to the club at the next meeting.

### **D.THE LOAN SUB-COMMITTEE:**

This is to help members financially, a loan of not more than ₦ 2,000,000.00 (two million naira only) shall be given to an eligible member.

- a. The club's Loan Sub-committee would administer the loan through a Standard Operating Procedure (SOP) that would be updated as the need arise.
- b. The loan administration will be run using the SOP which contain the details; some of the requirements are:
  - i. An application fee and filled application form
  - ii. A repayment cheque
  - iii. Collateral (verifiable)
  - iv. Indemnity via an Irrevocable Power of Attorney
- c. The loan will last for 4 (four) months.

**E. THE ENTERTAINMENT SUB-COMMITTEE** comprising: the PRO, Provost and one member. it should be their responsibility to plan, prepare and ensure that our constitutional provisions are met, and we get maximum value for money spent.

**F. AD-HOC COMMITTEE:**

Shall be set up by the club for specific purposes, and shall be dissolved as soon as its assignments are completed.

The following shall be

**Ad-Hoc Committees:**

- i. Constitution Review Committee
- ii. Audit Committee.
- iii. Reconciliation Committee

## **Section 8**

### **11.CONDUCT AND DISCIPLINE**

- a. Any member or officer that is adjudged guilty of embezzlement or misappropriation of funds or property shall be made to refund the sum so embezzled or misappropriate.
- b. In the event that the offender fails or neglects to pay the sum the club reserves the right to use its disciplinary committee or other means to recover the said sum and with fines as determined by the club.
- c. The club may also institute an action in any civil or criminal court to recover its funds or write the offender's town union.
- d. Any member who is guilty of A & B shall be disqualified from any elective position, and shall be barred from taking any position of honour.

- e. Any member or officer of the club who disposes or deals with any of its property in a manner which is inconsistent with the club's constitution, if unable to justify his action, shall vacate his position. No member has the authority of the club to enter into any agreement or negotiation on the club's property.
- g. No member shall be allowed to enter into any legal dispute with a member no matter the weight of the offence, rather it should be presented to the club.
- h. Any member engaged in litigation with the club whether as plaintiff or defendant shall be suspended from the club, until the determination of the suit.
- I. It shall be an offence to obstruct the executive or any of the club's ad-hoc committees from the performance of its lawful duties. An offender shall face the club/disciplinary committee to determine the penalty.
- j. On the death of a member, any member who decides not to travel home, without excuse granted by club shall pay a fine as stated in the constitution.

- k. Any member who bears false witness against the club or lay false accusation against it, or betrays the modesty and integrity of the club shall be made to face the executive as the jury. An appeal could be taken to the club to determine the fine depending on the gravity of the offence. the executive will determine the fine.
- I. Any member who defends any wrong doing of another member or shields him, shall be liable to a fine of fifty percent (50%) of fine of the defaulter or more, depending on the circumstances or gravity of the offence.
- m. Any member who is caught stealing money or property of another member shall be handed over to the police.
- n. Any member who is indebted to the club and has failed to pay, the cub shall take legal action.
- O. The disciplinary committee shall have the right to investigate any erring member referred to it and may prescribe any, or some or all of the penalties defined in this constitution and may in addition or in lieu, recommend suspension for any length of time or outright dismissals.

- p. A member under suspension shall NOT be entitled to any benefits.
- q. A suspended member may be recalled from suspension after he has been cleared, and shall pay all accumulated dues, levies and penalties.
- r. The club reserves the right to impose penalties or other sanctions not specifically dealt with by the constitution provided such offences are incidental or ancillary to the offences prescribed by the constitution.
- s. Any absconded member who decides to rejoin, shall pay back all the dues, levies and contributions accumulated during his abscondment, and pay a penalty deemed fit by the club.
- t. The acceptable clothing at our sittings shall be neat and smart attires; while for events shall be complete traditional or western attires.



## Section 9

### A. **FINES**

- a. Any member failing or neglecting to pay his dues and levies within the stipulated time, will pay such dues or levies with penalty of 20% of the sum per month. Defaulters on dues in every meeting will pay ₦ 3,000.00 (three thousand naira only) fine.
- b. A member who leaves the meeting while it is in progress without the permission of the provost, shall pay ₦ 500.00 (five hundred naira only).
- c. Absenteeism from meeting shall attract a penalty of ₦ 3,000.00 (three thousand naira only)
- d. Any member who fails to attend meetings for three consecutive times without a written permission; the club will write a letter after the three months to the defaulting member & if he did not respond and attend the subsequent meeting, he shall cease to be a member of the club.
- e. Members shall not engage in the use of abusive words or exchange of insults during meetings. an offender shall be liable to a fine of ₦ 1,000.00 (one thousand naira only).

- f. Fighting among members is strictly prohibited. Any member or group of members found or reported to have fought at meeting or in any gathering such members or group shall pay a fine of ₦ 5,000.00 (five thousand naira only) per head, upon settlement, the member(s) adjudged to be guilty shall pay an additional fine of ₦ 5,000.00 (five thousand naira only).
- g. Lateness to meeting ₦ 1,000.00 (one thousand naira only).
- h. Noise making or distraction attracts ₦ 500.00 (five hundred naira only).
- i. Phone ringing out during meeting attracts ₦ 500.00 (five hundred naira only).
- j. Absenteeism from traveling during funeral at the village ₦ 20,000.00 (twenty thousand naira only).
- k. Absenteeism from event here in Abuja attract ₦ 5,000.00 (five thousand naira only).
- l. Any member that invites a non-member in our midst during any outing will pay a fine of ₦10,000.00 (ten thousand naira only). The Provost should be vigilant to direct and guide non-members to avoid such situation.

## **Section 10**

### **RIGHTS AND BENEFITS OF MEMBERS**

#### **A. DEATH OF A MEMBER**

1. Members shall give, the death of a financial member, the required attention it deserves.
2. On the death of a member, every member shall pay a condolence levy of ₦30,000 (thirty thousand naira only).
3. The club is to transport the body of the deceased member to his home town and take the responsibility of the conveyance of the corpse to its final resting place.
4. A condolence purse of ₦1,500,000.00 (one million, five hundred thousand naira only) and a presentable live cow shall be given to his family.
5. A coffin of ₦150,000.00 (one hundred and fifty thousand naira only) shall be provided by the club.
6. We shall visit his Abuja home for condolence and repeat visitation for his wake keep.
7. Wake keep in the village is mandatory; the club shall set convergence and departure time during the wake keep.
8. Absence: at wake keep in the village attracts a fine of ₦5,000.00 (five thousand naira only).
9. We shall assemble at a location near the mortuary, and a relevant club representative shall be in contact with a key representative of the dead member, we shall join the convoy accordingly
10. Failure to join the convoy attracts a fine of ₦2,000.00 (two thousand naira only).
11. After church and burial ceremonies; We shall undertake same day the funeral of our dead member.

## DRINKS:

**Wake Keep Abuja** - 10 (ten) cartons of beer, carton of Mac dowl hot drink, a carton of Andre rose wine, 3 (three) bottle of Jameson black whisky, 10 (ten) cartons of water, and a crate of malt;

**Wake Keep Village** - 5 (five) cartons of beer, 5 Five cartons of water, and 3 (three) bottles of Jameson black whisky;

**Funeral at Village:** - 10 (ten) cartons of water, 2(two) crates of malt, I (one) carton of non-alcoholic drink and 3 (three) bottles of Jameson black whisky;

**Food-** Onugbu and Egusi soups with meat, wheat and Semolina, a, Ukwa, Echa, fried rice, and chicken pepper soups at not more than the sum of ₦ 250,000.00  
(Two hundred and fifty thousand naira only)

### B. DEATH OF A MEMBER'S WIFE

15. On the death of a member's wife, a condolence purse of ₦ 1,000,000 (One million naira only) shall be presented; and members shall contribute ₦20,000.00 (twenty thousand naira only) each.

- ii. We will provide our drinks and also take care of our feeding, the executive to decide.
- iii. The day of funeral shall also be the date for our condolence visit.

**A. DEATH OF MEMBER'S PARENTS OR FOSTER FATHER**

- I. A condolence purse of ₦ 700,000 (seven hundred thousand naira only) shall be presented.
- ii. A carton of these brands (Gulder, Star, Heineken Hero, Malt) & Andre rose wine.
- iii. We shall make available one carton of Andre Rose and 3 bottles of Jameson black whisky, 3 bottles of baileys, two cartons of non-alcoholic wine and five gallons of up palm wine for our consumption.
- iv. The celebrant shall entertain us with food and drinks in buffet standard.
- v. We shall continue to attend to one foster parent per member.

**B. DEATH MEMBER'S CHILD**

- i. Age limit should be 5 years and above
- ii. A condolence visitation, of all members to the deceased parents
- iii. A cash of ₦100,000.00 (one hundred thousand naira only).
- iv. We shall entertain ourselves on drinks only.
- v. B/w 6 months and 5 yrs., delegates would be sent with a cash sum of ₦50,000.00 (fifty thousand naira only).

**C. CHILD DEDICATION**

- i. A cash sum of ~~₦~~ 100,000.00 (one hundred thousand naira only) shall be given if we are formally invited.
- ii. The celebrant shall entertain the club.
- iii. All feeding entertainment should be by buffet in all occasions.

**D. We shall attend to invitations like wedding of biological child, wedding anniversary, house warming, chieftaincy, thanksgiving and child dedication.**

1. The invitation is with 6 (six) bottles of Andre rose wine;
2. At the event, the member shall provide us with Soup-based food, and at least 1 (one) other type of food, 2 (two) bottles of Jameson black whisky, half carton of Andre rose wine, 4 (four) bottles of baileys, 2 (two) cartons of non-alcoholic drink and 1 (one) carton of mixed beer;
3. We shall give the member an envelope with ~~₦~~200,000.00 (two hundred thousand naira only) content.

## **Section 11**

### **SOCIAL WELFARE OF MEMBERS**

- a. A member who has a financial problem of any kind should be assisted with the sum of ₦500,000.00 (five hundred thousand naira only). He will continue to return the said money in installments after 2 months, via return of ₦100,000 (one hundred thousand naira only) each month.
- b. In case of any member who has a problem/case of any kind should be assisted by the club, we shall use our connections provided it is not criminal, fraudulent or murder cases.
- c. A hospitalized member must notify the club formally through the executive, if the member spend between two days to one week in the hospital, we shall give him ₦50,000.00 (fifty thousand naira only)

and if he stays beyond one week in the hospital, we shall give him, an extra ~~N~~50,000.00 (fifty thousand naira only).

- d. Any member affected in any of the above should notify the Chairman or PRO officially.

## **Section 12**

### **ELECTION**

- a. Every financial member shall be entitled to vote for or/and to be voted for in any election conducted by the club.
- b. Elections into the executive shall be conducted once every 4 (four) years at our annual general meeting or monthly meeting and election shall be by simply majority of votes casted by financial members present at that meeting.
- c. The presiding member at any meeting shall cast his vote in the event of equality of votes, to determine the winner.
- d. No officer shall hold office for more than two (2) consecutive terms.
- e. An officer may be re-elected to another office after serving out two terms in one office.



- f. Other rules of voting: the election shall be as prescribed and approved by the club.

## **Section 13**

### **LOSS OF MEMBERSHIP**

A member shall lose his membership of club If;

- a. He voluntarily terminates his membership;
- b. He cease to attend meetings for three (3) consecutive times without written notice;
- c. He, is expelled from the club;
- d. He, as a distance member, and cease to attend meeting 3 (three) time in a year, or;
- e. He dies.

A member having lost his membership may apply to be re-admitted on the payment of ₦ 50,000.00 (fifty thousand naira only), if his application is brought within three months of his termination, the application shall be treated as a fresh application for membership, the person must clear his outstanding debts before readmission.

## **Section 14**

### **RESIGNATION/REMOVAL FROM OFFICE.**

- a. An officer who wishes to resign from his office shall do so by giving to the club, a notice of resignation, one (1) month before the effective date of resignation. And must state why he should do so for the club to decide.
- b. An officer may be removed from office on a motion supported by 2 (two) financial member and by a (2/3) majority votes of members present at the meeting.
- c. The successor to such vacated office shall be appointed or elected at the general meeting. The appointment/election of the successor takes effect immediately.
- d. Refusal to accept an office or carry out the function of an office after due election or appointment without cogent reasons, shall be treated as an act of insubordination by the club
- e. An officer who resign or is removed from office shall within 48 hours of such resignation or removal handover all properties of the club in his possession to the club.

## **Section 15**

### **A.FINANCE**

The finances of the club shall be made up of dues, levies, donations, gift (fines), interests on loans and as may be determined by the club.

### **B. BANK ACCOUNTS**

The club shall maintain saving or current accounts deposit with any of the financial institution generally agreed by the club.

The Chairman with the Treasurer and Financial Secretary shall be signatories to all bank accounts; either of the two shall sign on behalf of the club.

The club would have internet access to its bank accounts and it must have a hardware token for security.

### **C. AUDITOR**

- a. 3 (three) financial members with an accounting knowledge not being executive member shall be elected periodically as auditors to the club.
- b. The auditors shall report thereupon whether the account as prepared and presented show a true and correct view of the financial state of the club.

- c. Paragraph **a** and **b** shall be subject to any other arrangement for the auditing of the club's account as may be approved by the club.
- d. The financial year shall run from 1<sup>st</sup> day of January to 31<sup>st</sup> day of December each year.

## **Section 16**

### **CONCLUSIONS**

- a. No other benefit or rites shall be entertained or claimed by the member of the club, except as provided for in the constitution.
- b. The club may, on the recommendation of the executive or Board of Trustees, give award to deserving member for outstanding services to the club.
- c. To this effect, a Merit Award Committee may be setup by the executive.
- d. It is mandatory for the Chairman and Secretary to sign all, up to date constitutions.
- e. This constitution is subject to review as the need arise.
